FACILITY USAGE POLICIES

1. Facility members are required to present their membership card to staff at the main reception, and for gym users, at the gym reception when entering the gym.
2. No individuals under the age of 16 years of age are permitted in the immediate gym area without prior permission from the gym staff.
3. Gym users are required to use suitable training apparel and footwear at all times when exercising (e.g. no workbooks, dirty outdoor shoes, jandals, sandals or bare feet permitted, and training in the gym without a shirt is not permitted).
4. A towel must always be used when using the gym (if you do not have one, they can be hired from the gym reception) and all sweat must be immediately wiped off machines when finished using the machines.
5. If gym users are unsure about, or do not know, how to properly and safely perform any exercise, they are encouraged to seek qualified advice for the gym staff.
6. In the gym, weights and other equipment (e.g. dumbbells, bars, balls) are to be returned back to their correct locations after use.
7. Weights are not to be dropped on the floor, or to be rested on exercises benches, at any time.
8. Exercises machines should not be occupied when resting if others are waiting to use them.
9. Facility users are asked to be considerate to other users and follow safe exercise practices to reduce the possibility of injury to themselves or others.
10. Facility users are asked to notify the staff as soon as possible if they notice that any piece of equipment is broken or not functioning properly, so that the problem can be corrected as soon as possible.
11. Food, except for nutritional supplement bars, is not to be consumed while in the immediate gym or pool area.
12. The consumption of water and sports drinks in water bottles or other appropriate containers, is permitted.

Informed Consent

I acknowledge that I have read and understood the above facility usage policies, and I agree to fully abide by them. If I do not adhere to the above policies, I understand that, in the first instance, I will receive a verbal notification, then a verbal warning in the second instance, and then a written warning for a third repeated incident. Any further incident may result in a temporary suspension of my access privileges to the facility for a period of time at the discretion of Aqua Management Ltd. I also understand that a deliberate, intentional or serious action or behaviour that risks the safety of other facility users, staff or the myself, or should I cause wilful damage to facility, will result in immediate and permanent loss of my access privileges to the facility.

I acknowledge and accept that Aqua Management Ltd does not accept any responsibility for any personal injury, damage or loss to facility users, which are caused by my own negligent behaviours or actions when using the facility.
